(1) Set and hold a hearing, upon ten days notice to Respondent(s), to inquire into the matters alleged in this Petition.

(2) Require Respondent(s) to attend such hearing and to bring with them to Court the within- named child.

(3) Grant such other and further relief as may be just and proper.
